- for organizing transport from the nearest airport to the official hotels and back, and from official hotels to the competition venues and return, for Delegates, listed Referees, and Teams, according to Rule JU-WP 8.1.

**The Federations of the nominated Referees are financially liable:**

- for the travel expenses of their Referees
- for accommodation expenses plus per diem of 100 Euro per day, of their Referees according to European Aquatics Regulations, from 13<sup>th</sup> until 17<sup>th</sup> March or 18<sup>th</sup> March if travel on 17<sup>th</sup> March is not possible.

Also, they are responsible for informing the Organising Federation about the Travel plan of their appointed Referee.

**European Aquatics shall be financially responsible:**

- for the travel expenses of the appointed European Aquatics Delegates from 13<sup>th</sup> until 17<sup>th</sup> March or 18<sup>th</sup> March if travel on 17<sup>th</sup> March is not possible.
