The **Organizing Federation is financially responsible:**

- For the accommodation in F/B for the European Aquatics Delegates, plus a daily allowance as stated in the relevant European Aquatics Regulations and the official event agreement, from the 23<sup>rd</sup> of August until the 1<sup>st</sup> of September 2024.  
The appointed Delegates should arrive in their Hotel on 23<sup>rd</sup> August 2024, latest until 16:00 hours. In case that this is not possible it is recommended to arrive one (1) day earlier.
- For organizing transport from the nearest airport to the official hotels and back, and from official hotels to the competition venues and return, for Delegates, listed Referees, and Teams, according to Rule JU-WP 8.1.

**The Federations of the nominated Referees are financially liable:**

- For the travel expenses of their Referees.
- For accommodation expenses plus per diem of their Referees according to European Aquatics Regulations, from the 23<sup>rd</sup> of August until the 1<sup>st</sup> of September 2024.  
The appointed Referees should arrive in their Hotel on 23<sup>rd</sup> August 2024, latest until 16:00 hours. In case that this is not possible it is recommended to arrive one (1) day earlier.

Also, they are responsible for informing the Organizing Federation about the Travel plan of their appointed Referee.

**European Aquatics shall be financially responsible:**

- for the travel expenses of the appointed European Aquatics Delegates from the 23<sup>rd</sup> of August until the 1<sup>st</sup> of September 2024.
